5. President's Speech

President Mr. Lal Premanath stated that it's his 5th year being as the President of DCPA, Colombo Branch thanked all the members for their support extended to the Association, since founded in 1986.

He detailed the activities carried out by the committee during the year focusing the "Future Vision" formulated in 2014 governing 2 areas of activities i.e. School Development and Development of Colombo Branch, and expressed his sincere gratitude to Subcommittee Chairman's and members for their untiring efforts to achieve success in all events.



He expressed his gratitude on behalf of DCPPA, Colombo Branch to Dr. P. Warusawithana and his family for accommodating 6 Executive Committee meetings during the year at his residence and those hosted the meetings which resulted in no association funds were spent for meetings.

7. DCPPA Colombo Branch Trust Fund

On behalf of DCPPA –Colombo Branch Trust Fund, Secretary Mr. Piyal de Silva thanked Mr. Jayatissa Bandaragoda for his contribution towards the development and mentioned that Rs.5.5million is available in the Special Fund and could fund 20 scholarships per annum and also 4 merit awards for most deserved students.

He further stated that, no complaints what so ever received from parents on selection procedure.

Mr. R.G.L de Silva & Mr Gunasiri questioned on the travelling expenses incurred by trust Fund. Mr. Piyal de Silva explained that travelling expenses incurred were for the 20th anniversary of the Trust held in 2016, as Trust decided to invite donors who have been contributing during the last 20 years and major portion in connection with visiting more than 30 houses of the shortlisted applicants in and around Ambalangoda to verify the accuracy of their family income etc., He further mentioned that Mr. K.M.G.R. Chaminda present Trustee, the very 1st Trust Awardee has been providing his own vehicle for house visits where fuel cost is met by the Trust. Further most of the Trustees use their own workplace resources with no cost to the Trust Fund. Mr. Piyal stated that he will inform Trust Chairman of the complaint on transport expenses how we could minimize it.

Mr. Jayantha Kodikara said that the expenses are justifiable and Mr Mahinda Deshapriya requested to bear the Trust Fund administration cost by the Association and not to spent Trust Fund collections for administration expenses

Mr. Gunasiri questioned how many of the awardees have joined DCPPA, Colombo Branch. Commenting on this query Mr. Piyal Stated that very few have joined in spite of sending the membership application of DCPPA, Colombo Branch along with the approval letter for the selected awardees. The fact that Trust is not empowered to force them to become members; it is their duty to pay the gratitude by joining the Association. Further he said that today's younger generation does not bother of such gratitude.

Projects & activities for the year 2017

In continuation with Future Vision of Dharmasoka College Past Pupils' Association, Colombo Branch, formulated in year 2014, it's with pleasure we summarize the activities carried out during the year .

Trust for Higher Education and Scholarships

The prime objective of our Trust is to promote the advancement of education of the students of Dharmasoka College. Trust has so far focused on providing scholarships to needy students entering any University in Sri Lanka.

As the Trust has been dependent on voluntary donations offered by our past pupils and a few well-wishers, its major challenge was offering scholarships to a selected number of applicants in such a manner that the system is sustainable over time.

Trust published a brochure including the list of donors, as well as the list of scholarship recipients, during last 20 years, from 1996, the first year of its operation, up to 2016.

Accordingly, a total of **406** scholarships have been granted during this period with the assistance provided by 126 donors.

The Trust has endeavored to gradually increase the level of annual scholarship grant on 3 occasions, from an initial Rs. 6,000/- in 1996 to Rs. 7,200/- and subsequently to Rs. 8,400/- & thereafter to Rs. 12,000/-. With the recent increase in 2017, the scholarship amount is Rs 15,000/-. These disbursements were possible through funds derived from two ways: (1) bank interest accrued from lump-sum "Special Fund" donations kept as Fixed Deposits, and (2) Individual sponsors offering to cover the value of a scholarship for a period of three years.

In addition to 20 scholarships to students from low income families, the Trust also grants 4 merit awards every year for Physical Science; Biological Science; Commerce; and Arts students who have obtained highest Z scores in above streams based on the instructions of College authorities.

After many years, Trust decided to increase Merit awards grants to be effective from 2017 as stated above to Rs 15,000/ per annum per recipient Further it is with pleasure we announce that, with the assistance from College authorities and strategic planning & hard working by Trustees, award ceremony was concluded within the same year i.e before end of the year 2017. Hence from 2018 onwards we are confident to complete awarding process within the same year.

The significant incident at the last year award ceremony was donations from Old Sokians. 2 existing donors uplifted their Special Funds while 2 Old Sokians created Special Funds. Thus Special Fund status as at 31st March 2017 has risen to Rs 7,753,143/=. We would like to place on record a new donor Mr G.L De Silva family has donated Rs One Million to a new Special Fund while Miss. Kalyani De Silva, daughter of late Lt. Col N.E. De Silva donated Rs 450,000/- for a new special Fund, in memory of her late Sister Miss G.L. Chandrani Damayanthi De Silva. In addition existing Special Fund of Lt. Col N.E.De Silva Memorial Scholarship Fund was increased to Rs 500,000/-, while Trustee Mr K.M.G.R.Chaminda uplifted his Special fund to Rs 225,000/-.

Also Perth Group of Old Sokians domiciled in Western Australia donated to create a Scholarship fund in 2000 and they increased their fund to Rs. 450,000/- which enable them to award a scholarship every year.



A number of awardees have sent their letter of appreciation to the Trust and to their donors, as they reap the benefits derived from the scholarship. We appreciate such gesture of gratitude by the recipients.

Web Management

The Subcommittee headed by Prof. Nihal Kodikara was appointed to upgrade the existing website with the initiative of DCPPA, CB, with an ultimate intention to cluster the entire Sokian community under one platform, using latest technology combined with intensively used social media networks by many generations, focusing to provide up-to-date information to members and also to entire I Sokians.

Main features of the web site would be to provide information of activities undertaken by DCPPA, CB and activities of the school, member's data base for the reference of members, easy and quick communication, to archive the 31 years of records of DCPPA with many additional features to help the membership. The new web structure could be integrated with other main websites operated by affiliated groups to enable users to reach centralized information with ease.

Mr. Shamie Uyange has already completed the full structure with a face lift at no cost to the association and will launch the first module being the DCPPA. CB at the AGM with available information and expected to be completed within 6 months.

Executive Committee requests the support of the membership with any valuable information to be intergraded to the site.

Special invitee Mr. Wasantha Deshapriya, expressed his views on the proposed website and recapped the importance of a comprehensive web site with social media to attract younger generation and with up-to-date useful information to users of any age.

Updating the IT Lab

Prof. Nihal Kodikara ventured to repair and upgrade 23 computers in the main lab and 16 computers in the junior lab at no cost with the assistance of university students.

Mr. Wasantha Deshapriya has already initiated to provide the school with a MicroBit Computer system which will be very helpful to children from grade 7 upwards and a long term plan will be implemented to refurbish one computer lab exclusively to cater to AL students following IT and 2 other computer labs.

Membership drive.

The Executive Committee applauds the efforts of Mr. Udaya Sirisena, Chairman of the Subcommittee for achieving the millstone of enrolling 100 new members to DCPPA, Colombo Branch and further 4 members were enrolled on 1st February 2018 and his commitment to new enrollments will continue.

As proposed by Mr. Rohana Chaminda, DCPPA, Colombo Branch is focusing on issuing Loyalty Card to members and to offer privilege's from fellow Sokian's. Mr. Saman Warusawithana gracefully volunteered to award Rs. 50,000/- to initiate the matter.



Annual Trip

The Subcommittee headed by Mr. Gavesh Gnige, organized the night out trip **on 14th and 15th October 2017** to Diyathalawa Army Camp as the Annual Trip of the DCCPA, CB with invitations to general membership to join and was a joyful stay in Diyathalawa.

The Reunion 2017 organized by Subcommittee headed by Mr. Jayanatha Kodikara was successfully held on 23rd September 2017 at Grand Monarch at Thalawathugoda.

At this event, five senior members of the Association namely Mr. S.K. Chandrathilake, Mr. R G L De Silva, Mr. S.W. Jayasooriya, Mr. Lakshman Perera and Mr. Piyadasa Hettihawa were honored for their outstanding services during the past.

Also, Captains of the National Cricket Mr. Upul Tharanga and Mr. Dinesh Chandimal were felicitated at the event.

Sports Activities

In addition to financial assistance to students who achieved excellence in sports activities, DCCPA, Colombo Branch contributed to hosting the lunch for payers, officials and invitees at the Big Match held at Tyrone Fernando stadium at Moratuwa. When the committee along with Mr. Wasantha Deshapriya met the Principal, they discussed in detail the need of long term strategy to develop the ICT sector of the college and the proposal to be implemented during 2018.

Also, Dr. Deshapriya Wijethunga will conductg a program on Sustainable Development for the students of O level and A Level in May 2018.



Fund Raiser

The Executive Committee made untiring efforts to conduct Sing Alone musical event and a stage play "Lowrancege Manamali" during the year to raise funds for its activities. Infrastructure Development Fund

Infrastructure development projects are in progress of at Dharmasoka College initiated by DCPPA, Colombo Branch.

- Construction of three storied building for Staff welfare
- Refurbishment of the Science Lab and Staff Wash Rooms
- Erection of the statue of "Mudliyar Thomas de Silva", the Founder of the school.

Total Estimated Projects Cost: Rs 11 million

Status:

Contractors (for the Building, Statue and Staff Wash Rooms) were selected by calling bids from short-listed Contractors.

Staff Wash Rooms have been completed at a total expense of Rs. 950,000/-.

Construction of three-storied building at an estimated cost Rs 9,000,000/-, is in progress and work has been completed up to 1st floor slab level. As per the revised work schedule, building will be completed and handed over to College in August, 2018.

Image of the Mudliyar Thomas De Silva has been done to the satisfaction of the Subcommittee and the final wok is in progress. Statue will be completed in end March 2018 at a cost of Rs 700,000/-.

Apart from the special fund-raising events, many old Sokians have made monetary contributions for this special "Infrastructure Development Fund". This gesture is extremely praiseworthy and therefore, the DCPPA Colombo Branch Executive Committee is much grateful to those who have already contributed and request other Sokian's also to contribute as they wish which will enable us to complete all the tasks within the anticipated time frame.
